



**THE RULES
OF THE I INTERNATIONAL WORKSHOPS:
DANCE AND MOVEMENT
11 – 24 August 2019**

GENERAL INFORMATION

1. The organizer of the I International Workshops: Dance and Movement is the Cultural Centre in Rybnik-Chwałowice.
2. The workshop is scheduled for August 11-24, 2019.
3. The workshops may be attended by adults working as professional dancers, acrobats and aspiring graduates and students of dance departments in Poland or abroad.
4. The workshops last 2 weeks in accordance with the attached schedule.
5. The workshops will take place at the Cultural Centre in Rybnik-Chwałowice and at other facilities that co-organize the I International Workshop in Rybnik.
6. The organizer provides accommodation and meals for the duration of the workshops.
7. There is no possibility to pay for a selected week of the workshop. Payment is for two weeks, from 11th to 24th of August.
8. Selected participants are required to perform at the final show of the workshop, which will take place at the Market Square in Rybnik. The show will be an artistic creation consisting of two parts: choreography prepared by participants under the supervision of Marjon van Grunsven and a choreography prepared by Anna Krysiak. Workshops and rehearsals are held in accordance with the attached schedule.

REGISTRATION

1. The subscription runs from 15/04/2019 to 31/05/2019. The results of the recruitment will be announced until 08.06.2019 on the website of the Cultural Centre in Rybnik-Chwałowice.
2. The application is made by filling in the application form, available on the website of the Cultural Centre in Rybnik-Chwałowice and optionally sending a links to the videos that is the portfolio to the e-mail address: dkchwalowice.biuro@gmail.com
3. Before sending the application, please read the schedule of the workshops.
4. The number of participants is limited.
5. The amount of free places can be changed due to the removal of people from the list who did not pay the fee.

RULES FOR QUALIFICATION OF PARTICIPANTS

1. The workshop participants will be selected by the members of the commission, which includes one representative of the Cultural Centre in Rybnik-Chwałowice and one representative of the MOVYTZA Art and Recreation Centre.
2. The decision on the selection of participants by the committee is final and irrevocable.
3. In justified cases, the Organizer reserves the right to make changes to the regulations.



PAYMENT

1. Participation in the workshop costs PLN 2000. The price includes accommodation in the hotel and meals.
2. The participant is obligated to pay the fee for the workshop up to 7 days after receiving the official electronic message about the acceptance of the workshop.
3. If it is found that the fee has not been credited to an account after 7 days from the enrolment, the participant will be removed from the list.
4. The payment can be done in cash or by bank draft:

 - e) to obtain an invoice, it is necessary to fill in the required fields in the application form.

RESIGNATION

1. Resignation need to be done exclusively in writing to the e-mail address: dkchwalowice.biuro@gmail.com
2. In relations to the resignation of people who paid the workshops fee, the Organizer:
 - a) refunds 50% of the workshops fee minus transfer costs if the resignation has been done before 30th of June 2019 (includes 30th of June);
 - b) does not refund the payment if the resignation has been done after 30th June, 2019
 - c) does not refund the payment if the resignation has not been reported.
3. People who are entitled to reimbursement are asked to write in the resigning form the account number to which transfer is to be made.
4. The recovery of cost resulting from the resignation are done after the end of workshops.
5. Other cases will be considered individually.

NOTICES

1. It is recommended to have an individual Accident Insurance. The Organizer does not liable for any accidents caused by the participant, as well as for lost or damaged possessions.
